LOUIS (BOTH MISSOURI AND ILLINOIS) BY PROVIDING AN ARRAY OF SERVICES SUCH AS PARENT AND YOUTH SUPPORT GROUPS, TRAININGS AND WORKSHOPS, EDUCATIONAL ADVOCACY, NEWSLETTERS, ETC. IN 2016, 91 CHILDREN (83%) REMAINED IN THEIR FOSTER/ADOPTIVE HOMES WITH THE HELP OF FAMILY WORKS AND 103 CHILDREN, 82% OF THOSE SERVED BY 30 DAYS TO FAMILY, WERE PLACED WITH KIN BY CASE CLOSURE. IN 2016, 168 YOUTH, 88% OF THOSE RECEIVING EDUCATIONAL ADVOCACY SERVICES MET THEIR EDUCATIONAL GOAL AND 152 FAMILIES WERE REFERRED FOR FOSTER CARE OF ADOPTION LICENSURE.
